5. Confidentiality

Your complaint will be handled by the Council's Monitoring Officer in accordance with the procedure for handling complaints against Councilors and Co-opted Member.

The Council encourages complainants to provide their name and contact details. If the complainant asks for their identity to be protected, the Council will not disclose such details without their consent.

However, in relation to your name, the Monitoring Officer will normally pass a copy of your complaint to the Councilor complained about so that he/she can comment. It is also in the interests of fairness and natural justice that a Councilor complained about should have the right to know who has made the complaint and what it is. In very exceptional circumstances, the Monitoring Officer may agree to withhold your name. He/she would only do this if he/she has a good reason to believe that to give your name to the Councilor would be contrary to the public interest or would prejudice any investigation.

6. Additional Help

Complaints must be submitted in writing. This includes submissions by email. However, we can make reasonable adjustments to assist you if you have a disability that prevents you from making your complaint in writing.
